Dear Mr Nicholas,

I refer to the visit to the SSAA Para Branch grounds on the 31st of October 2019 and subsequent inspection of your club's ranges and facilities by Firearms Branch Range Officer Alex Haines.

The inspection found the grounds of the club to remain in good order with evidence of regular ongoing maintenance being conducted. An updated Range Certificate has been enclosed which lists those activities/disciplines approved for conduct on your club grounds. The range certificate is to be displayed in a prominent position at your club whenever shooting activities are taking place. Alternately, this certificate may be stored in the club files and a high quality copy be displayed.

After due consideration, the club's request for the approval of the new Air Rifle Field Target range is granted subject to the following conditions:

Air Rifle Field Target:

- Only air rifles up to .22 calibre are approved for use on the range
- Only Air Rifle Field Target shooting activities are approved for use on the range
- While Air Rifle Field Target activities are being conducted on the shotgun range there is to be no movement forward of the 200 metre mound on the 300 metre range
- To be shot in accordance with the SSAA Official Air Rifle Field Target Guide.

The club's shooting disciplines continue to be approved subject to the following conditions:

Extended Range Rimfire Silhouette:

- Approved to be conducted on the 300 metre range
- To be shot in accordance with Extended Range Rimfire Silhouette local competition rules as submitted to Firearms Branch on 9 October 2018.

Gallery Rifle:

- Approved to be conducted on the 50 metre range
- Targets to be placed at the base of the mantlet
- Ammunition limited to a maximum velocity of 1400 fps
- Only pistol calibre straight walled ammunition may be used.

- Approved to be conducted on the Shotgun range
- Shooting cages must be used
- Only shooting cages of the design approved by Firearms Branch are to be used
- Shooting cages must be adjusted to limit the arc of fire so that no projectile can land on the adjoining rifle range
- Shot size is limited to no greater than number 7 or 7.5
- All activities must be under the control of qualified range personnel.

Sighting in of high performance large calibre firearms:

- Only the two right hand side firing line benches of the 300 metre range are approved for use
- Only the right hand side of the 300 metre backstop which is fitted out with overhead and side coverage is to be used
- Only timber target frames, paper or cardboard targets, set back inside the opening of the backstop/catchment area are to be used
- Only the calibres listed (.338 Lapua, .375 Cheytac, .408 Cheytac, .416 Barret, .460 Steyr) on your correspondence of 2 December 2010 are approved for use
- Only financial and active members of SSAA Para Branch Incorporated are approved to use high performance large calibre rifles of a calibre approved by the Delegate on the SSAA Para Branch Incorporated range
- All persons using this portion of the range for the sighting in of high performance large calibre rifles approved by the Delegate must be under the supervision of a SSAA Para Branch Incorporated range officer
- The firing of rifles for this activity must only be conducted from baffled firing positions that have had appropriately manufactured and adjusted baffles fitted to the existing baffle systems located immediately in front of the shooting positions
- Members wishing to use this facility for sighting in rifles of the calibres noted above must make an appropriate booking with the range administrators and must be supervised during any such activity
- The use of full metal jacket, steel cored, solid brass or solid copper projectiles is not approved.

Centrefire Scoped 3 Position Rifle:

- Includes NRA 3 Position any sight match

.22 Rimfire Scoped 3 Position Rifle:

- Includes Scoped Air Rifle, 10 Metre Precision, 10 Metre 3 Position, BR 30 & Air Rifle Metallic Silhouette.

Gallery Lever Action Rifle:

- Pistol calibre ammunition – limited to 1400 fps.
